ONE TIME CHARGES:

Membership Charges

Single Family Residence (SFR):	\$7,000.00
Multiple Family Residences (MFR) and Commercial, First 2 Units:	\$7,000.00
Each Additional Unit (see Note 1):	\$3,500.00

Note 1: "Additional Unit Fee" applies to MFR and commercial buildings with separate keyed units and/or separate addresses. MFR includes duplexes, and apartments. Commercial includes business, government, school, church, and community facilities.

Fire Protection (for each square foot over 3600): \$ 1.40/sf

Note 2: Additional charges will apply if installation requires re-paving, excessive excavation and/or shoring, de-watering, flaggers, or hydroexcavation equipment.

Note 4: Premises Isolation is included on 3/4" and 1" services and drop-in.
